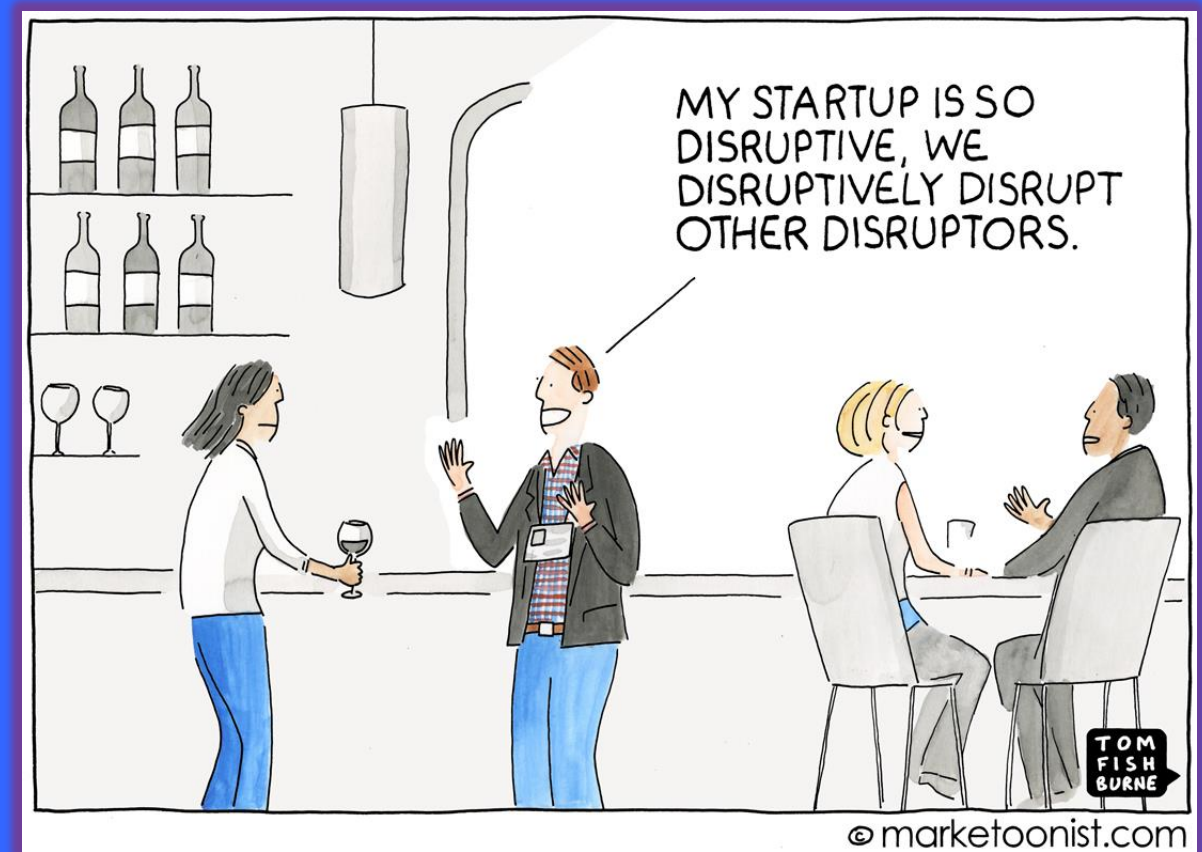

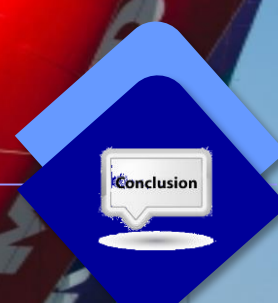

Digital Disruption: Introduction and Concept

*Let's face three different concepts which are used interchangeably with a big issue on top, the term **disruption**.*

Disruption
• Disturbance that interrupts an event, activity or process

Disruption
• Disorder, upset, trouble, dislocation, perturbation

Disruption
• Rupture, breaking, breakdown, breakup, breach

Technology
• The application of scientific knowledge for practical purposes, especially in industry.

Innovation
• the application of better solutions that meet new requirements, unarticulated needs, or existing market needs. • A new idea, device or method

Digital
• Digital economy, an economy based on computing and telecommunications resources • Digital refers to something using digits (binary digits)

Disruptive Technology
• refers to any enhanced or completely new technology that replaces and disrupts an existing technology, rendering it obsolete.

Disruptive Innovation
• is an innovation that creates a new market and value network and eventually disrupts an existing market and value network, displacing established market-leading firms, products, and alliances. Christensen.

Digital Disruption
• Digital disruption is a change in industry value triggered by advances in information and communications technology

- Even though I am a big fan of evolution and change, my first reaction to this topic is to say, why are we accepting, using and causing **DISRUPTION** with our innovations and technologies and digital discoveries?
- The big issue on top of our innovations (digital or not) is the **acceptance** of the term **DISRUPTION** as a norm of "business as usual".

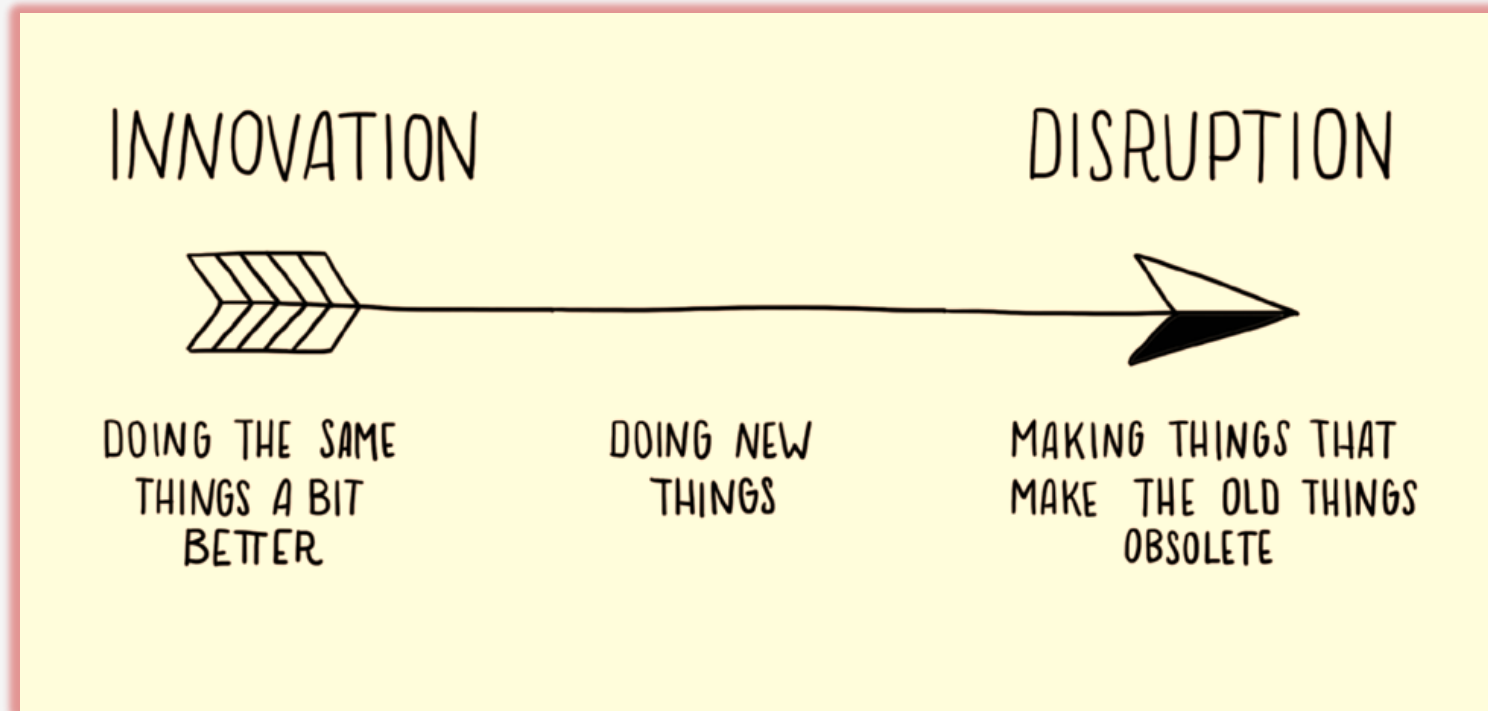
Is the purpose of our businesses to cause disruption to humanity or to cause a balanced evolution?

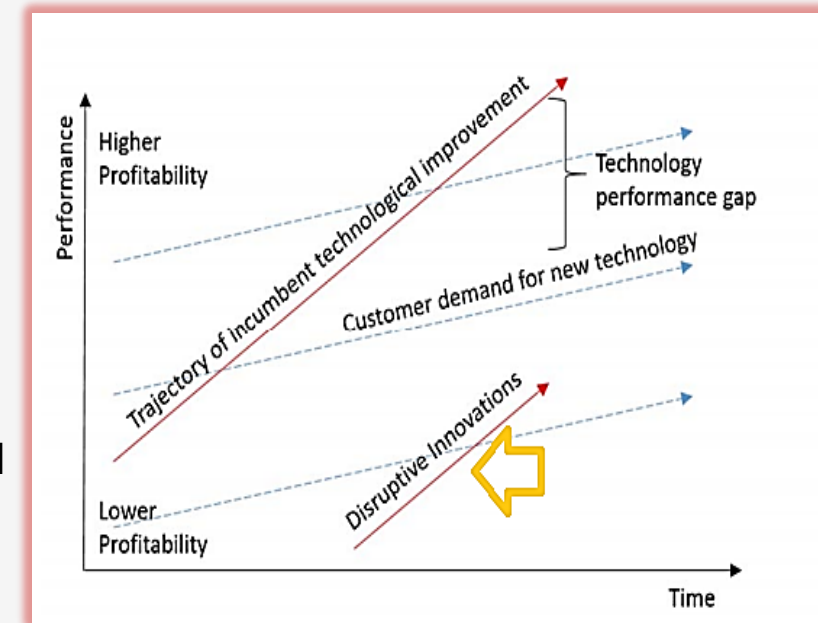


Digital Disruption: Introduction and Concept

The definition of Disruption from Christensen, Raynor, Altman and McDonald (2015) from the perspective of business and competition:

"Disruption describes a process whereby a company with fewer resources is able to successfully challenge established incumbent businesses. Specifically,

- As incumbents focus on improving their products and services for their most demanding (and usually most profitable) customers, they exceed the needs of some segments and ignore the needs of others.
- Entrants that prove disruptive begin by successfully targeting those overlooked segments, gaining a foothold by delivering more-suitable functionality— frequently at a lower price.
- Incumbents, chasing higher profitability in more-demanding segments, tend not to respond vigorously.
- Entrants then move upmarket, delivering the performance that incumbents' mainstream customers require, while preserving the advantages that drove their early success.
- When mainstream customers start adopting the entrants' offerings in volume, disruption has occurred." *Christensen, Raynor, and McDonald (2015)*

Clayton Christensen and Joseph Bower introduced his first idea of "disruptive technologies" in his article *Disruptive Technologies: Catching the Wave*.

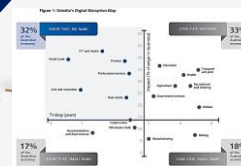
1995



In 2009, Milan Zeleny described high technology as disruptive technology and raised the question of what is being disrupted.

By 2012, Deloitte identified digital disruption as "transforming the way companies and agencies operate and how they engage with their customers". Deloitte launched Deloitte Digital.



Harvard Historian, Jill Lepore criticized Christensen in *The Disruption Machine*. She wrote its case in *The New Yorker*.

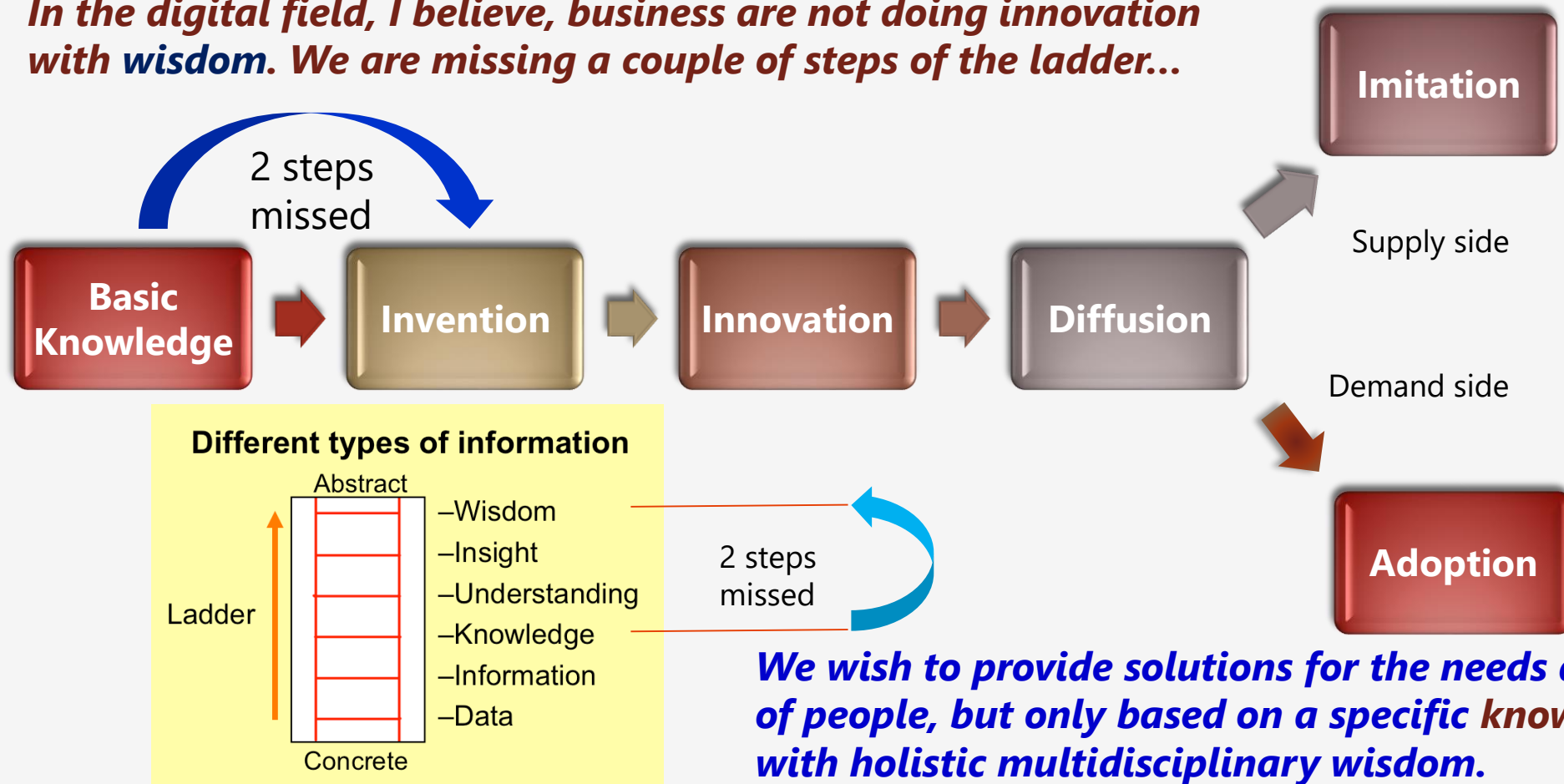

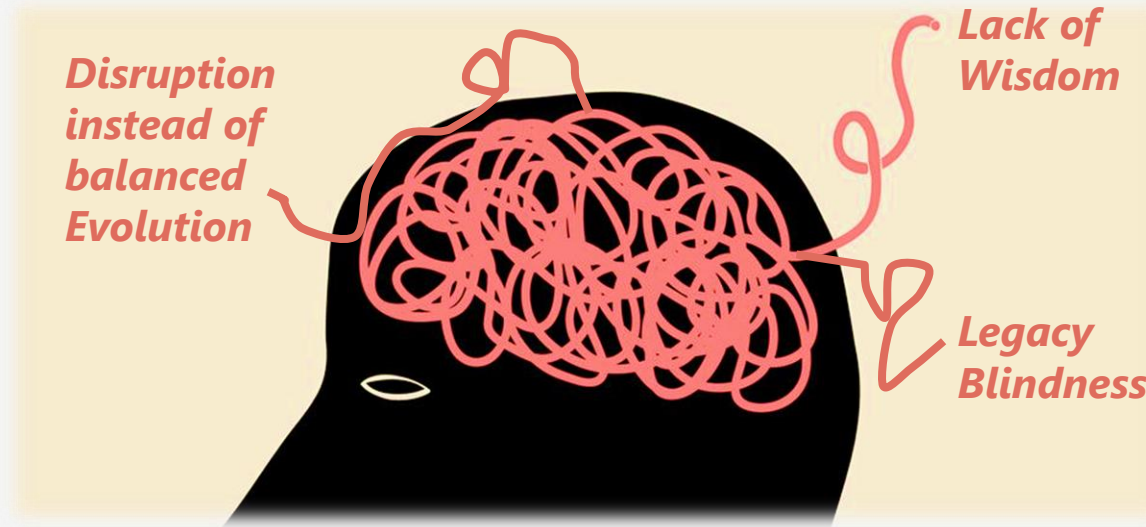
*In the digital field, I believe, business are not doing innovation with **wisdom**. We are missing a couple of steps of the ladder...*





Digital Disruption: Introduction and Concept

It seems to me, business leaders are doing business decision making with capped minds...



Lack of Wisdom: First of all business owners are doing businesses or deciding about which businesses to pursue, with *capped minds*. We trigger, promote and do inventions and innovations based on basic knowledge, not based in wisdom.

Legacy Blindness: Second, business owners create or pay others to help them to decide without discernment in terms of the consequences for the next 4 generations.

Promoting Disruption instead of Balanced Evolution: We are all the time rushing to disturb instead of promoting equilibrium

It is possible, Digital Disruption is a term coined after the Christensen Disruption Technology definition. In consequence, the concept of Digital Disruption follows the same tendency.

Digital disruption is the change that occurs when new **digital** technologies and business models affect the value proposition of existing goods and services.

The wrong consequences of high-speed disruption (no matter what type of it) is of at least two general categories:

Internal (to the human being)	External (societies and economic)
Depression and anxiety	Unemployment
Hypertension	Increase inequalities
Obesity – causing diabetes, metabolic syndrome, heart disease	Poverty Family destruction
Sleep deprivation	Cyber-security Issues-Lack of Privacy
Stress	Risks associated with destruction and wars
Isolation-social chaos	Immigration

- Digital Disruption is defined in a way that we are not creating balance or harmony of planet earth.
- It is a non-ended agony to put our brains at service of disruption.
- We are disrupting all the time the delicate balance of our humanity.
- We are creating products and services at higher velocities than what our own mental models evolve.
- Again we are rushing the next generations to grow old **too fast**.
